2. In these Offer Terms "we", "us," "our" or "HSBC Bank" means HSBC UK Bank Plc.

Eligibility criteria for the bonus points

3. To be eligible for the bonus points, the following requirements must be met:
 - a. You must successfully apply for the eligible Card. Successful applications for other non-eligible cards will not qualify for the bonus points offer;
 - b. The Card account must be opened on or after 5 June 2026 and one or more purchases to the total value of at least £500 completed within 90 days of the date the card was opened. Any amount which is refunded or reversed before we assess your eligibility for the bonus points will not count towards the minimum transaction value; and
 - c. The Card account must remain open at the date the bonus points are applied.
4. If you meet the eligibility criteria for the bonus points (as described above), your points will be applied to your Mastercard Pay With Rewards account within 90 days.
5. The Offer Period is from 5 June 2026 until 3 July 2026. Any HSBC Credit Card applications received by us before or after the Offer Period will not qualify for bonus points.
6. We will offer one bonus per Credit Card Account opened. Additional cardholders are not eligible for bonus points.
